1. Background:

- 1.1 DAIS is hosting a YRS conference themed 3S's. This conference aims to build awareness of the environmental changes and empower them to contribute to sustain / improve the same. Besides it will also provide students with a forum for experiencing cultural differences and creating friendships.
- 1.2 DAIS is committed to safeguarding and promoting the welfare of children and young people and expects all visitors to share this commitment. For the welfare and safety of the School's pupils and visitors, DAIS will permit participation in the 3S's YRS conference on the terms provided below.
- 1.3 The 3S's YRS conference, period will be from 10th October 2014 to 12th October 2014.
- 1.4 All delegates from your school agree to abide by the laws of India and to respect the culture and social expectations of the country and its people.
- 1.5 Each delegate from your school is covered by an adequate international travel insurance policy applicable in India. (Only for schools outside of India)

2. Staff Delegate:

- 2.1 In this agreement "Staff Delegate" means the adult individuals from your school who are accompanying your students for the 3S's YRS conference.
- 2.2 DAIS reserves the right to refuse to accept any Staff Delegate who would, in the reasonable opinion of DAIS, be undesirable.
- 2.3 Your School will be responsible for the actions of Your Staff Delegates, including managing any issues with regards to standards of behaviour which are not in compliance with the terms of this agreement.
- 2.4 Staff Delegates will remain in charge of your students throughout their time at the conference and are responsible for their supervision at all times in accordance with the expectations of DIAS.

3. Student Participants

- 3.1 In this agreement 'Student Participant' means each and all of your pupils who are or will be attending the 3S's YRS conference.
- 3.2 DAIS reserves the right to refuse accept any Student Participant who would, in the reasonable opinion of DAIS, be undesirable.
- 3.3 Your school will be responsible for the management and control of Your Student Participants, including managing any issues with regards to standards of behaviour which are not in compliance with the terms of this agreement.

4. Provision of Information

You will provide DAIS with written details of Your Student Participants, of any relevant medical conditions, disabilities and/or special educational needs of Your Student Participant and of contact details for their next of kin. In addition, your school shall ensure that such information is given to each of your Staff Delegates who are aware of it at all times during the 3S's YRS conference period.

5. Conduct

- 5.1 All Participants are expected to participate in the 3S's YRS conference with a positive and purposeful attitude. Your School, the Staff Delegates and Student Participants are required to comply with any instructions given by DAIS's staff during the conference, for the smooth conduct of the conference.
- 5.2 Student Participants are required to behave courteously at all times, conform to the norms of good conduct and respond readily and cheerfully to requests concerning good order and discipline that may be given from time to time by members of the staff of DAIS.
- 5.3 Student Participants are expected to show due courtesy to others who are physically challenged or are much younger in age, especially in the use of common facilities.
- 5.4 DAIS will not tolerate inappropriate behavior by any Student Participant including overt displays of affection and the use of obscene or vulgar language.
- 5.5 Smoking, any form of gambling, drinking alcohol, drug use, etc. are strictly prohibited.

6. Supervision

In order to ensure that adequate arrangements are made for the supervision, welfare and protection of Student Participants for the 3S's YRS conference, You are responsible for ensuring that the Student Participants are adequately supervised (subject always to any instructions received from DAIS's staff) and for contributing positively during the conference. For the avoidance of doubt your school is responsible for ensuring that all Your Student Participants remain under the overall responsibility of an identified Staff Delegate and that they are able to contact that person in an emergency.
